

A homestay involves staying in either a single or shared room at the home of an Australian family. It is a great opportunity for you to immerse yourself in the English language and Australian culture, either for the duration of your study, or while you find your own accommodation.

Working in Australia

As an international student, you may work study session and unlimited hours when your course is not in session. Permission to work is automatically included in your student visa. Although you are able to work in Australia, you cannot rely on that income to fund your tuition fees or living costs for the duration of your stay in Australia. Many international students choose to work part-time during their studies, but it is unrealistic to expect that you will find part-time work as soon as you begin looking for it. You will first need to become familiar with the city and the areas where part-time employment is available. It is also important to understand your study obligations before you commit yourself to part-time work. For more information, please visit: studyaustralia.gov.au

Health Cover

Overseas Student Health Cover (OSHC) is insurance that provides cover for medical and hospital care which you may need while you are in Australia. OSHC will also pay for most prescription drugs and emergency ambulance transport.

If you are an international student studying in Australia and have a student visa, you must purchase an approved OSHC policy from a registered health insurance company - commonly referred to as health funds. You will need to buy OSHC before you come to Australia, to cover you from the day you arrive. It is a student visa condition that all students maintain OSHC throughout their stay in Australia.

Be aware that while OSHC represents excellent value in health insurance, it does not cover every medical circumstance or cost. You should note the exclusions given in the product description.

You are encouraged to use the services provided by our local agents who understand this process. The main documents required are:



- → Medical Examination Results
- → Proof that the OSHC (Overseas Student Health Cover) has been arranged
- → Proof of financial capability to pay tuition fees and living expenses

Student visas are granted with certain conditions attached, including that you must:

- → Satisfy course requirements must attend a minimum 80% of all scheduled classes and make satisfactory academic progress
- → Remain enrolled at all times
- → Inform your education provider of any change of address
- → Contact your current education provider if wanting to change institution within the first six months of commencing the principal course

PART 1 - SCOPE, PURPOSE AND DEFINITIONS

SCOPE AND PURPOSE

- The terms and conditions of this Agreement apply to all international students who accept an offer of enrolment to a course of study at Western Sydney University International College.
- This Agreement applies to courses registered with CRICOS by Western Sydney University International College (CRICOS provider number 03663C).
- 3. This Agreement, and the availability of complaints and appeals processes, does not remove your right to take action under Australia's consumer protection laws (ESOS National Code, Standard 3.2.d) as well as your right to pursue other legal remedies.
- 4. This Agreement should be read in conjunction with: 4.1. ESOS Legislative Framework (click here to view or download); 4.2. Western Sydney University International College's obligations under the Simplified Student Visa Processing framework; 4.3. The following Western Sydney University International College
- policies (**click here** to view or download):
- Admissions Policy;Enrolment Policy;
- Student Fees and Refunds Policy; and
- Progression and Examinations Policy.
- **5.** This Agreement is provided in accordance with the ESOS Act and the ESOS National Code.

DEFINITIONS

6. For the purpose of this Agreement, the following definitions apply:

PART 2 - ENROLMENT AND FEES

ENROLMENT CONDITIONS

- **7.** As a condition of your enrolment at Western Sydney University International College, you agree to:
- 7.1. Pay all your tuition fees in accordance with this Agreement or as directed by Western Sydney University International College to maintain your enrolment and CoE.
- 7.2. Complete your enrolment by the agreed starting day for each of your sessions. You acknowledge that if you fail to do so, Western Sydney University International College is required by law to notify the Department of Home Affairs by cancelling your CoE. This may lead to the cancellation of your student visa.
- 7.3. Commence your course of study on the commencement date set out in your Letter of Offer and CoE. You acknowledge that if you fail to do so and have not been approved for a deferment of your course of study:
- your offer of admission will lapse;
- your CoE will be cancelled;
- you may be required to lodge a new application for admission to Western Sydney University International College; and
- you may incur additional fees.
- 7.4. Apply to Western Sydney University International College Admissions in writing no later than the census date if you wish to defer your studies and provide evidence of compelling or compassionate grounds for the deferral (National Code 13.2). In these circumstances, you agree to follow the procedure prescribed in Western Sydney University International College Enrolment Policy and Admissions Policy. 7.5. Ensure that your study load in every teaching session will enable you to complete your course of study within your current visa period. Western Sydney University International College may be unable to issue your CoE if you reduce your study load without approval.

- 7.6. Pay the tuition fees for any additional units studied (including units repeated) at the rate that applies when you enrol in these units.
- 8. If you are a continuing student but do not enrol in your compulsory study session by the agreed starting day you will be regarded as having abandoned your course. You acknowledge that in these circumstances Western Sydney University International College is required to start a process that may lead to the cancellation of your CoE. The cancellation of your CoE may lead to the cancellation of your student visa by Department of Home Affairs.

 - **13.3.** any other fees as prescribed by Western Sydney University International College for your course, including the non-refundable deposit if you are a packaged student.
- **15.** You accept and agree that, as a commencing student, you are not eligible for a payment plan, or extension of time to pay tuition fees under any circumstances.
- 16. If you are a packaged student, you agree to pay a non-refundable deposit, as specified in your offer letter, to Western Sydney University International College and which shall be applied towards your principal course of study at Western Sydney University. You acknowledge that your deposit will not be refunded other than in the circumstances set out in this Agreement. The deposit must be paid before Western Sydney University will issue your CoE.

Important: Western Sydney University International College assesses international applicants against Genuine Temporary Entrant and Genuine Student requirements as defined in Ministerial Direction 53 issued by Department of Home Affairs. Western Sydney University International College is obliged to safeguard against applicants who are not genuine and will not refund your deposit except in those in circumstances set out in this Agreement. You will not be eligible for a refund if you request to transfer to another institution without meeting the requirements of a release in accordance with Standard 7 of the National Code. You acknowledge and agree that your deposit will be credited towards your tuition fees for your principal course.

Continuing Students

- 17. You agree that it is a condition of your continued enrolment at Western Sydney University International College that:
 16.1. You pay all tuition fees in full by the due date.
 16.2. You cannot re-enrol after the agreed starting period of the teaching session of study unless you first obtain permission from your
- 18. If you do not pay your tuition fees by the due date Western Sydney University International College will cancel your enrolment, unless you apply for and are granted an extension of time to pay in accordance with the procedure set out in the Student Fees Policy.

PART 3 - REFUNDS

OVERVIEW

- 19. If you are eligible for a refund of any tuition fees paid to Western Sydney University International College under this Agreement, you may apply for a refund by completing and submitting the Fee Refund Form to Western Sydney University International College Admissions.
- **20.** Applications for refund of Western Sydney University International College tuition fees are accessed strictly in accordance with terms of this Agreement.
- 21. If approved, refunds are paid in Australian dollars.
- **22.** All withdrawals are subject to the prescribed Western Sydney University International College withdrawal timelines and penalties.

REFUND WHERE WESTERN SYDNEY UNIVERSITY INTERNATIONAL COLLEGE DEFAULTS OR OFFER IS WITHDRAWN

- 23. In the unlikely event of a Western Sydney University International College default, or that your offer of a place is withdrawn, you are entitled to a refund of all tuition fees already paid but unused, unless: 22.1. you have withdrawn or discontinued prior to the day of the Western Sydney University International College default; or 22.2. you have accepted another offer at Western Sydney University; or 22.3. the circumstances specified in the Student Fees and Refunds Policy (No Refund) of this Agreement apply.
- 24. If Western Sydney University International College offers you a place in another course of study, you may accept that offer, rather than apply for a refund. Any fees already paid including any deposit will be credited towards tuition fees payable for that other course of study.

REFUND BEFORE STUDENT VISA IS APPROVED

- 25. If your application for a student visa is rejected by Department of Home Affairs, the lesser of \$500 or 5% of unused tuition fees paid to Western Sydney University International College will be retained and all other course fees will be refunded. If you have paid your OSHC directly to Western Sydney University International College, the University will process your OSHC refund. Otherwise you will have to claim a refund directly from your OSHC provider.
- 26. If you withdraw your application for a student visa after you accept an offer from Western Sydney University International College but before your student visa is granted, you may apply for a refund of all tuition fees paid except in the circumstances specified in clauses 32 and 33 (No Refund) of this Agreement. Western Sydney University International College is entitled to charge an administration fee of \$AUD200 for processing your application. You authorise Western Sydney University International College to deduct this amount from any tuition fees already paid. You will be required to provide evidence of the withdrawal of your student visa application when you apply for a refund.

REFUND WHERE STUDENT DEFAULTS

- 27. If you do not commence your course of study on the commencement date, and you have not previously withdrawn from your course of study with approval from Western Sydney University International College, your CoE will be cancelled and your entitlement to a refund will be calculated in accordance with this Agreement, if you apply for one. For that purpose, the date of your withdrawal will be considered to be on the day of the course commencement date.
- 28. If you are a packaged student with an approved student visa and you withdraw from your course(s) of study, you may not be entitled to a refund of your deposit for your principal course at Western Sydney University. For more information, please see the Western Sydney University Refunds Policy.
- **29.** If you are a continuing student and you withdraw before the due date, you may apply for a refund of all unused tuition fees.

REFUND WHERE STUDENT OBTAINS PERMANENT RESIDENCY

30. If you are an international student who, after commencing your studies but before the census date for that teaching session, receives approval from Department of Home Affairs to change your visa status to permanent resident, you may be entitled to a refund of fees in certain circumstances in accordance with the Student Fees and Refunds Policy. Any entitlement to a refund will be calculated from the date that you inform Western Sydney University International College of your change in status. Please note that Western Sydney University International College cannot change your status to permanent resident after the census date under any circumstances.

NO REFUND

- You are not entitled to a refund of any tuition fees if:
 The Department of Home Affairs cancels your visa for any reason, including a breach of a condition of your visa;
- 31.2. Any documents or information submitted by you or on your behalf as part of your application for admission or your application for a student visa are, or later found to be, fraudulent; 31.3. You are suspended, excluded or expelled from Western Sydney
- University International College following a finding of misconduct; 31.4. You withdraw from a course of study after the census date in any teaching session, including preliminary courses for
- **31.5.** Your enrolment is cancelled by Western Sydney University International College due to your failure to pay your tuition fees by the due date (including if you are granted an extension of time):
- **31.6.** You withdraw from a unit of study for which tuition fees have been paid, but without permission to reduce your study load, and then subsequently withdraw from a course of study.
- **32.** As a packaged student, you are not entitled to a refund of any deposit paid for packaged courses except as set out in this Agreement.

UNUSED TUITION FEES

packaged students:

- **33.** You may be entitled to a refund of any unused portion of paid tuition fees if:
 - **32.1.** upon completion of the requirements of your course of study, you have a credit balance of tuition fees; or
 - **32.2.** you fail to meet the Western Sydney University International College academic progression rules and are subsequently excluded from your course of study.
- 34. If you withdraw from a unit of study at Western Sydney University International College before the census date, any portion of unused tuition fees will be credited towards another unit of study in the same course. If you withdraw from your course entirely, you will only be entitled to a refund if you first obtain permission to reduce your study load before withdrawing from the course.

35. If you are a packaged student and you do not successfully complete the entry requirements for the University component of your study package, you can apply for a deferred commencement for the next intake of the course of study. This will enable you to complete the preliminary course to satisfy the University entry requirements. You acknowledge that you cannot use the deposit applied to your principal course to cover tuition fees to satisfy entry requirements. Your non-refundable deposit will be held in credit and applied towards your principal course of study.

REFUND OF OSHC

36. You accept and agree that you must make your own arrangements to apply for a refund of any OSHC directly with the OSHC provider.

REFUNDS IN EXCEPTIONAL CIRCUMSTANCES

- 37. Western Sydney University International College may consider an application for a refund in circumstances other than those set out in this Agreement only if you can demonstrate and provide evidence of compassionate or compelling circumstances beyond your control. For further quidance, see: National Code Standard 13.
- 38. Western Sydney University International College reserves the right to require you to comply with its reasonable requests in relation to the provision of sufficient evidence to demonstrate exceptional circumstances. This may include, but is not limited to, attending upon any medical practitioner, counsellor or other health professional.
